- F. Senior Inquiry EPC Subcommittee White Paper to EPC for review Discussion:
 - SI Committee developed to assure equity across departments
 - It is crucial that SI is supported by EPC
 - College has student learning outcomes and SI could be used as an assessment tool
 - Have departments articulated learning objectives for SI
 - Should a student be required only one SI
 - How are we tracking the SI issues
 - Consider a committee consisting of members from Nom and Rules, EPC, Assessment.
 and GenEd
 - SI learning outcomes may not be the same within departments
 - Faculty time commitment for SI
 - How are resources allocated within departments
 - Are we using our resources in an appropriate manner
 - Set an agenda and create a dedicated structure to carry out the agenda
 - Are writing, research abilities being assessed
 - One department alone cannot solve procedural issues
 - Aid departments in developing and staffing of SI
