AGENDA ITEM I – APPROVAL OF MINUTES

The minutes of April 7, 2009 Educational Policies Committee meeting were approved as presented.

AGENDA ITEM II – NEW BUSINESS

A. <u>Honor Code Proposal</u>

Mike Green, Emily Jacobs, and Courtney Ward joined to committee to discuss proposed changes to the Honor Code. There is a possibility of incorporating an additional stage in the process before a full hearing. Use this as an educational opportunity for minor infractions, especially for first-year students new to an academic community. Honor Code was written, adopted, and voted on by students. Do changes require students to revote on this? What feedback from faculty is needed? Several clarifying points that are changes to the document were discussed. This year the Honor Council has used more "creative" sanctions, such as social probation, hours in the Reading and Writing Center, a required paper on plagiarism. This document will move on to Faculty Senate for approval.

Motion-Kaul, Second-Wolf APPROVED "To approve the Honor Code Proposal as amended."

B. <u>Attendance Guidelines</u>

Mike Green explained that this guiding document is coming forward because the feedback from students, faculty members, and parents demonstrates a lack of clarity or consistency in attendance guidelines. Percentages represented are within the typical range of where conflicts arise. This could be used as a guiding document to developing a course policy, which new faculty comment that they need some direction with. This document addresses only excused absences. What would happen if a student misses a classroom experience that could not be made up through other outside classroom make-up work. This document will be brought up for discussion at the next Faculty Senate meeting. No motion to approve was made.
