The EPC Committee discussed the following concerns regarding *Programs* at Augustana.

- *Programs* approval process
- Location of *Programs* on the website and catalog
- Presentation of *Programs* clearly defined in catalog and website
- Ask Admissions to clearly categorize *Programs* when information is supplied
  - to incoming students
- Public presentation of *Programs* information
- How are *Programs* listed in the Advising Folders
- Separate *Programs* with distinct identification markings

**III. A.** New Business:

Pre-Library Science professional studies program

Carla Tracy, Augustana Library Director, offered the following information to support the Pre-Library and Information Science Advising Program:

- Informal meeting with students interested in possibility of continuing education in Library Science
- Faculty Welfare Committee suggested a possibility of raising a profile of librarianship as a career opportunity
- Librarians are in demand
- All Disciplines of study can be brought to the program

**Action:** EPC recommended: Carla Tracy consult with Katie Hanson to discuss the section in the Advising Program <u>Courses recommended for the first year or second year</u> and to include the following statement; "Students interested in becoming a Media Specialist (k-12) and seeking teacher certification should consult the Education department before registering for these courses". It was further requested to add under <u>Additional Courses</u>, ENGL 332. EPC Chair will request revisions be resubmitted.

#### IV. For Discussion:

A. Outcome of Teagle Pilot program to date: upcoming submission of an immersion Program Dr. Kevin Geedey and Dr. Reuben Heine are preparing a basic 9- or 10-credit structure for three courses intertwined into one program, for fall term 2010-2011. A proposal will be submitted for course content and grading. The immersion will be a 300-level experience for students meeting requirements.

Liesl Fowler commented regarding the immersion grade on transcripts. A term comment, indicating program and included courses, can be indicated on the

transcript. **Concerns noted by the Committee**: Cost of immersion program, future of the program, condition of the grant, and number of students involved (relative to faculty FTE commitment).

## C. Pre-Physician Assistant Program with Biology Major

It was noted the Pre-Physician Assistant Program is a format to advertise types of courses offered at Augustana needed to make the students competitive when applying for programs. EPC is concerned why the decision was made by the SCI division to choose on-line voting.

ACTION: EPC is returning a revised proposal to the Biology Dept. and Science Division for approval of the following revision:

Chemistry 411 (Biochemistry - Must be taken fall term of 3<sup>rd</sup> or 4<sup>th</sup> year) *OR* a 300-level biochemistry course

## D. Pre-Chiropractic Program with the Biology Major

EPC discussion:

- Is endorsement of alternative medicine appropriate?
- Question of diversity of opinion within Chiropractic practice
- Consideration of advising tool for department but not to be listed on website or in catalog
- Is this being used for student recruitment
- EPC is concerned why the decision was made to choose on-line voting

# ACTION: Return to Division Chair to request further discussion. At this time no action by Committee

### **Discussion: EPC concerns:**

- whether programs or areas of study need to be vetted by a faculty group or committee
- website locations and catalog are not consistent and may appear misleading with regard to the listing of concentrations, majors, minors, coordinated-degree programs, advising programs, pre-professional programs, and tracks
- Concern with language in catalog on page 47 in 2009-2010 catalog
- Advising areas be distinctly defined in catalog and website

- Two distinct medias (catalog and website) of information should be consistent
- Explanation be clearly stated in catalog and website for the following: concentrations, majors, minors, coordinated-degree programs, advising programs, pre-professional programs, and tracks

## **ACTION: EPC will contact Augustana ITS:**

- to discuss process of maintaining website information consistent with the catalog
- possibility of linking all information so changes are made throughout the website once
- ITS contact person authorized to make changes
- Who may submit additions and request changes
