Joe McDowell and Dave Crowe joined the committee. Creative writing major has existed as ENGW – English with an emphasis in creative writing. The new proposal creates a new major within the department with the existing faculty with a stronger presence at the college. No new staffing is required. The new proposal is distinctive from others in that it is a full English major with many of the same courses as the English major and will enable us to place more graduates within top writing programs across the country, especially the Writer's Workshop at Iowa. The River Writers Program was a success, and it is hoped that it will continue. The above newly developed courses within the ENCW major stand approved with the program.

2. Music Composition - concentration

David Davies joined the committee. He explained that the courses are needed whether the concentration is added or not. SI was added a few years ago in preparation for this change. No new faculty needed at this time. Gradually, items will be added to the music library (housed either in the Tredway library or the music dept., depending on from which budget the funds came). Designation on transcript is Bachelor of Arts in Music – with a concentration in Music Composition. More students are interested, and one was turned away from participating under the current composition configuration. The first several courses are traditional lecture courses, followed by more labbased ones.
