The following are some topics and edits discussed about the survey. Detailed notes were taken by Rowen Schussheim-Anderson who will share them with Margaret Farrar.

- To further reduce, Whiteside confirmed that Registrar's office could allow LSFY Courses to be individually renumbered to accommodate suffix or LP attachment to them. Brian Katz felt the matrix for LSFY 103 is already full and different from the perspectives which convinces him that they should not have perspectives on them. A few 103 courses would qualify for D or G: African, Chinese Women, and Sharon Varallo's.
- How could those courses make the case for teaching our diverse and changing world in LSFY 103? Some would be able to be tweaked. Meg Gillette wondered how many 102 and 103 would qualify for LPs.
- It was suggested that all survey questions asking faculty to prioritize should be uniform. It was suggested the survey asked for 1-5 ranking, such as a Likert Scale.
- Should the physical education requirement be expanded in the survey based on Fred Whiteside's statistics

- Not shown here is adding LPs to 102 and 103. If we include D and G do we want to ask about LPs? Add another question: "3-term, full-year sequence where 103 courses are suffixed with LPs"
- Put comment boxes on the bottom of each page to explain why they voted the way they did.
